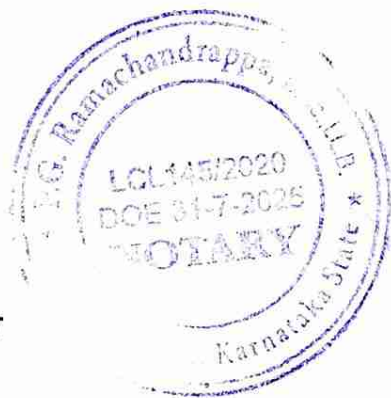





4.3 The trustees collectively shall constitute the board of trustees.




4.4 The first trust and second trustee shall be the managing trustees and shall hold office for life.

8. Properties and funds of the trust

The properties and funds of the trust shall be and shall consist of :

- 8.1 The sum of Rs.1Lakh (One laksh) onwoded by the author and trustees in cash for the general purpose of the trust.
- 8.2 Contributions , gift, grants aids (recurring and Non recurring) given from Government and / or other charitable institutions in India or Outside India, to the trust from time to time.
- 8.3 Contribution and gifts received from the public for the general purposes of the trust.
- 8.4 Contributions, grants and gifts received from local bodies and authorities.
- 8.5 Such other income, resources, receipts any kind or nature moveable and or immovable, in cash or kind furtherence of the object and purposes of the trust and
- 8.6 Accretions and income from the properties of the trust

9. Administration of trust :

All power of administration, mcontrol and authority in respect of the trust and its funds properties shall vest in the Board of Trustees under the authority of the Managing Trustees for the benefit of the achievement of the objective and purposes of the trust.

10. Application of Trust property:

The trustees shall not apply or transfer any of the properties, assets or funds of the trust for any purpose or object other those set in this deed. However if any trustee personally renders any service of the nature provided for this trust deed, he shall be paid such expenses as approved by a majority of the trustees.

11. Powers of the board of trustees:

Without prejudice to all such powers, rights, liberties and authorities, express of implied, necessary for incidental to or consistent with the powers for the implementation of effectuation of the objects of this trust, the trustees shall have power to




- 11.1 acquire hold and invest all or any part of the assets of the trust including immovable Properties and to decide all matters arising there from.
- 11.2 Decide all matters relating to the scope, objects and purposes of the trust.
- 11.3 Decide all matters touching relations and co-operation with other institutions, Government bodies, Universities or local authorities.
- 11.4 Open operates an account or account with bank or banks.
- 11.5 Constitute from time to time a committee/s consisting of one or more persons for Such period as the board or trustees may from time to time decide upon for Obtaining aid and advice, in carrying out the objects of the trust.
- 11.6 Determine sanction and allot recurring and non-recurring expenditure of the trust. Institution/s or establishment/s created under the trust and to decide and approve Capital and other expenditures. The board of trustees shall from such rules for the Conduct of their business and of the proceedings of their meetings as the trustees May consider proper and the same may from to time be amended altered or added as the case may be by the trustees.
- 11.7 Appoint a committee/s to advice and assist in respect of the governance and Administration of any institutions, establishments and the like created under the Trust. The committee/s shall consist of such members and shall have such powers and functions as may be prescribed by regulations farmed in that behalf from time to time by the board of trustees. The managing trustee shall have power to Constitute governing bodies for the day-to-day administration of the institutions and and establishment created under the trust, to delegate to such governing to time determining the powers and functions of the governing bodies created for the said purpose and the day to day administration of the institutions and establishments created under the trust. The managing trustees shall have power to dissolve the committee/s or governing bodies or remove any member of these bodies.
- 11.8 Appoint from time to time such staff assistants and / or employees on such remuneration and terms as they may deem fit for the administration of the trust.
- 11.9 Negotiate conclude and effectuate such agreements with state or Unio Government, Local bodies, Associations of persons Authorities institutions or other individuals for purposes of obtaining financial or technical aid or assistance on such terms and in such form as they deem appropriate for the furtherance of the purposes and objects of the trust.

- 11.10 Borrow funds from banks and / or other philanthropists for the purpose of the trust and to all acts necessary for the borrowal of funds.
- 11.11 Amalgamate the trust with their or trusts or may take over any other trust or trust created for similar purpose and which are recognized under section 80 of the income Tax Act 1961
- 11.12 Without prejudice to the general powers of the managing trustee to act on behalf of the trust the board of trustees may authorize the managing trustee to acquire, sell, mortgage or other wise alienate any immovable property of the trust, for the purposes of the trust.
- 11.13 All power vested in and exercisable by the board of trustees shall capable of being performed or exercised by a majority among the members of the board of trustees from time to time and any action or decision of such majority shall be valid and effective as if done by the Board Trustees.
- 12. Transaction of business by Trustees:
 - 12.1 The trustees shall ordinarily meet once in three month a after clear seven days notices, issued by the managing trustee or by such other person/s duly authorized by the managing trustees in this behalf.
 - 12.2 Subject to as here in other wise provided the trustee may meet as often as may be necessary or expedient for the conduct of the business of the trust. One of the managing trustees shall preside at the meeting of the trust. In the absence of the managing trustee/s, one of the trustees as may be decide upon by the trustee present shall preside at the meeting of the trust.
 - 12.3 The business of the trust may also be transacted by circulation.
 - 12.4 All the decisions of the trust may be taken by a simple majority. In the event of equality of votes at a meeting, the managing trustee or in the absence of the managing trustees, the trustee who presides at the meeting shall have a casting vote.
 - 12.5 The quorum for the meeting shall be two, when the number of trustees on the board is not more than four and shall be three when it is more than four.

13. Accounts and minutes:

14. Bank Accounts :

A Bank account/accounts shall be opened in the name of the trust and shall be operated by the managing trustee only First Trustee : Halanur S Lepaksh

15. Investment of trust Deed:

- 15.1 The trustee shall subject to provision of any law for the time being and from time in force relating to trusts, invest any part of the capital or income of the trust in such investment being the investments authorized by law and in particular by section 11(5) and 13(1)(d) of the income Tax Act 1961 and may sell or realize any such investment and obtain payment of any moneys so deposited as aforesaid.
- 15.2 All the investments made or here in after acquired shall be in the name of the trust by its managing trustees for the time being and in conformity with provisions of the income Tax Act 1961

16. Amendment to Trust Deed: Notwithstanding anything contained in these parents, the trustees shall have power to alter amend, add to or delete any clauses of this deed consistent with the objects of the trust provisions of sections 1(15), 11, 12, 13) and 80 (g) of the income Tax Act 1961 including the power to increase the number of trustees, provided that such changes shall not be made without the prior approval in writing of the Commissioner of income Tax having jurisdiction over the trust.
